

# General Terms and Conditions of Newsletter Subscription

## 1. General

With these General Terms and Conditions of Newsletter Subscription, Nexum d.o.o. (hereinafter referred to as “Nexum” or the “Company”) hereby determines the obligations, rights and conditions for the use and management of the data of subscribed users.

Natural and legal persons can subscribe to the newsletter via the registration form, in which they submit their contact details with the registration (obligatory e-mail address).

Nexum respects your privacy in accordance with the legal requirements and provisions governing personal data protection and undertakes to protect the data obtained with the registration form in accordance with applicable law and use it only for sales and marketing purposes and not transmit the data to unauthorised third parties.

## 2. Your consent to the collection and processing of personal data

By subscribing to the newsletter of Nexum d.o.o.:

- I agree with the General Terms and Conditions of Newsletter Subscription of Nexum d.o.o.;
- I authorise Nexum d.o.o. to establish, collect, manage, use, process and store my data, on the basis of the submitted data and other data about me as a newsletter user, in its contact files, in the manner and for the purposes described below;
- I declare that I am fully aware that I may at any time request that Nexum d.o.o. ceases to use my personal data for direct marketing and to send information materials. I declare that I will inform Nexum d.o.o. of this in writing to the e-mail address of the Company listed in point four of these General Terms and Conditions.

## 3. Purpose of data collection and storage

The purposes of data collection, processing, storage and use are of a marketing nature for informing about news, special offers, sending tickets for fairs, advertising material, magazines and invitations to events, telephone, written and electronic surveys and informing about activities, offers and prize draws and competitions, organised by Nexum or another legal entity that organises prize draws and competitions in cooperation with Nexum.

### 3.1. Prize draws and competitions

When Nexum organizes a prize draw or competition, data subjects will be informed of the purpose of the prize draw or competition and the consequences of participating. If Nexum publishes information about the winners, the participants will be informed in advance. When announcing the prize draws and competitions, Nexum will notify the participants in advance if it will also use the personal data for direct marketing and if the data obtained from the prize draws and competitions will be transmitted to any third parties.

Personal data is stored in electronic form until the withdrawal of consent. Based on a written withdrawal of consent by the user, the data are deleted and the data carriers destroyed.

#### 4. Unsubscribing from the newsletter

The user may cancel their subscription at any time by clicking the unsubscribe link in the received newsletter. The user can also unsubscribe from the newsletter and request the deletion of their contact data by sending a written request by e-mail to [marketing@nexum.si](mailto:marketing@nexum.si).

After the final confirmation of the user's unsubscription, we will delete all user data from the list of users and notify the user in writing of the deletion.

Any changes to these General Terms and Conditions will be published by the Company on its Website.
